# **D-SAACP Applicant Instruction Sheet**

## Welcome to the D-SAACP!

D-SAACP

The Department of Defense (DoD) is committed to providing a high quality response to sexual assault survivors. The DoD Sexual Assault Advocate Certification Program (D-SAACP) recognizes the critical support Sexual Assault Response Coordinators (SARC) and Sexual Assault Prevention and Response (SAPR) Victim Advocates (VA) provide to victims of sexual assault from initial report through case conclusion, or until the point the victim no longer requires assistance. SARCs and SAPR VAs certified through D-SAACP will join a growing field of certified civilian victim advocates who are trained and committed to upholding the highest standards of victim care and privacy.

## **Certification Requirements**

To become certified, all applicants must complete DD Form 2950 as well as one of the NACP-approved 40 hour training courses. Submit DD Form 2950 and your training certificate to the National Organization for Victim Assistance (NOVA) via mail, work email, or Fax. (Please see submittal instructions below.) All applicable parts of the form must be completed in their entirety. Depending on the position (SARC or SAPR VA) and the Level (I, II, III, or IV) you apply to, the requirements vary.

### Levels

Four D-SAACP Certification levels are offered for SARCs and SAPR VAs—Levels I, II, III, and IV. The minimum eligibility requirements for each level are outlined on the Application Form (page 2) of DD Form 2950. ## **Deadline for Certification**

All SARCs and SAPR VAs must be certified through the D-SAACP by the Congressional requirement of October 1, 2013 to provide sexual assault victim advocacy services. Applications are currently being accepted and will be reviewed in a quarterly and rolling basis. The deadlines for submitting applications for the quarterly D-SAACP Review Committee meetings are: 31 January, 30 April, 31 July and 31 October. The last date you can submit an application and be certified to meet the Congressional requirement is 31 July 2013.

## **Submitting the Application**

Please send the completed DD Form 2950, along with your training certificate, by one of the below methods. NOVA will send **the applicant** a confirmation email within 5 days of receipt.
