We in the field are writing to address some issues which have been bothering us for a while. This letter is prompted by the recent announcement of the National Child Care Benefit Project. It seems to us who have been involved in the Youth Program for some time that this project is a way for the National office to once again have (b) (6) Preturn to the program. This would be a disaster for many reasons.

was an ineffective National Youth Manager who did little to improve the support and resources provided to State Youth Programs and in fact usually added to our already heavy workload. Questions and concerns addressed to (b) (6) were given lip service but rarely followed up on. When she moved up and ran the larger contract which included GFAP and GFTB as well as assessments those worthwhile programs were either cancelled, modified, or completely changed and they too no longer provided anything of substance to the field.

Another concern to the field is that (b) (6) has been seen in different cities at National Guard Family events in compromising romantic positions (kissing, holding hands, one leaving the others hotel room in the early morning hours) with (b) (6) of the National Family Program Office while both proclaim to be happily (b) (6) to other people. This relationship has been alleged for a number of years while both were involved in the Family Program in Indiana and persons who were volunteers there speak of it frequently as an embarrassment to the state. Both were allegedly fired from their duties in Indiana and (b) (6) was recently fired from a National Family Program contract position.

It was also learned by our group that (b) (6) has recently emerged as a contract employee for the group Connect & Join who maintain an involvement in the National Youth Program and by proxy she has reestablished her involvement through her relationship with Mr. Conner.

We feel that the National Program has declined tremendously in the last year and in this letter we hope to raise the concern that the contracting process is being manipulated by Mr. Conner by working with a contractor in an effort to have (b) (6) return to the program. Our concern also extends to the fact that (b) (6) seems to have turned a blind eye to the state of the program and his personnel.


